#### **RESOLUTION NO. 14-8**

*WHEREAS*, the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania ("Township") enacted a certain ordinance No. 05-06 dealing with Connection and Tapping Fees on June 21, 2005 (the "Tapping Fee Ordinance"); and

*WHEREAS*, the Tapping Fee Ordinance provides that Connection Fees and Tapping Fees can be revised, from time to time, by Resolution of the Board of Supervisors of the Township; and

WHEREAS, the Township Engineer, Hanover Engineering Associates, Inc., has issued a Report of Connection Fee and Tapping Fee Computations dated August 19, 2014 (the "Report"), which Report indicates that the Township may adopt new Connection Fees and Tapping Fees consistent with the Report; and

WHEREAS, the Board of Supervisors of the Township has determined that it would be in the best interests of the Township to revise the Connection Fees and Tapping Fees consistent with the Report.

*NOW, THEREFORE, be it RESOLVED and it is RESOLVED* that the Board of Supervisors of the Township hereby revises and establishes Connection fees and Tapping Fees pursuant to Ordinance No. 05-06 as follows:
