BIRTHDAY & ANNIVERSARY DAYS

Effective with an employee's second year of employment the employee will be awarded two additional days off with pay. Employees will be allowed to take their birthday and work anniversary (employment date) day off. These days can be moved to either a Friday or Monday to allow for a longer weekend but *must be taken in the week in which they occur*. If the birthday occurs prior to the anniversary date, the birthday day off day commences the following year.
