

# This is Hanover, not Bethlehem!

What European settlers' first saw when they looked upon the land that now comprises Hanover Township, Northampton County, was a watersparse wilderness covered with scruboaks. It is hardly surprising, therefore, that they called it "The Barrens" or "The Dry Lands". By the early nineteenth century, however, Pennsylvania Dutch farmers had turned the area into some of the most fertile farmland in the state.

Originally, the Township was part of 23,000 acres which formed John and Richard Penn's "Manor of Fermor". In 1747, it became part of Allen Township, which was comprised of what are now Allen, East Allen, and the two Hanover Townships. Hanover Township was officially incorporated as a separate entity on August 8, 1798.

The Township acquired its present boundaries in 1812 when Lehigh County was created. At that time, Hanover was split into two separate townships with approximately one-third of the land and one-half of the population remaining in Northampton County.

Farming predominated Township life throughout the nineteenth century and into the twentieth. During that time, development centered around the village of Hanoverville in the east and Schoenersville in the west. Each had a tavern, a store, a post office, and a handful of dwellings. Power for grist and sawmills and a brewery was provided by the Township's only stream, the Monocacy, which flows along the southeastern boundary.

Until 1956, three one-room schools were the locations for the education of Township children. Schortz School, the oldest of the three, is located on Jacksonville Road, across from the present Hanover Elementary School. Knauss School stands in the northeastern section of the Township on Hanoverville Road directly behind Golden View Dinner. The third school, Rudolph, was located on Jacksonville Road near the Schoenersville Road intersection and now houses a Tanczos Beverages. In 1965, nine years after the

opening of Hanover Elementary School, Hanover Township joined with three other local townships and the City of Bethlehem to form the Bethlehem Area School District. A second elementary school, Asa Packer, was built at the western end of Stoke Park Road in 1967.

Population growth in the Township remained slow and steady until the 1920's when the trend toward suburbanization began. Hanover's population doubled between 1950 and 1960 and nearly tripled in the decade that followed. The 1990 Census showed 7,136 individuals living in the Township. During the next 10 years the population increased by 34% with the 2000 Census showing 9,563 residents.

Hanover Township today is a residential community with excellent recreation facilities, highlighted by the Hanover Township Community Center that opened in November of 1996. The township is located northwest of the City of Bethlehem allowing easy access to urban facilities. Well-planned employment districts are currently being developed, which will allow employment opportunities within the Township.

Hanover Township is a Second Class Township under the Pennsylvania Municipalities Planning Code and is governed by a five-member Board of Supervisors. The current board of Supervisors is comprised of John J. (Jay) Finnigan, Jr., originally elected in 1999, Dr. Frank Colon, originally elected in 1981, John N. Diacogianis, originally elected in 1984, after being appointed during 1984, Stephen R. Salvesen, originally elected in 1983 and Glenn R. Walbert, originally elected in 1984. The Township Manager, N. James Sterner is responsible for the day-to-day operations of the township. A thirty-six year employee of the Township Jim was appointed the township's first Township Manager in March of 1990. The Hanover Township Volunteer Fire Company #1 provides fire protection and police protection is handled by the Colonial Regional Police Department.

Good news was received just before the winter holiday; notification from the Pennsylvania Department of Education that Asa Packer has earned a performance award of \$8,280.00 for Maintenance of High Standards. This new state award is designed to recognize a school's sustained high achievement in the Grade 5 PSSA's over several years.

Ice skating instruction for fifth grades' physical education class as well as a PTO sponsored school-wide ice skating event at Municipal Ice Rink has fit well into the January weather patterns. ## Citizens Police Academy

On November 20, 2002 fifteen individuals graduated from the Colonial Regional Police Citizens Police Academy. The graduates comprised residents from Hanover and Lower Nazareth Townships and the Boroughs of Bath and Chapman.

The graduates participated in a six-week, one night a week program that was presented by members of the CRPD. The intent of the program was to;

- Familiarize citizens with the various functions of the police department
- Provide basis understanding of the role of the police in the criminal justice system and the role of the police in increasing the quality of life in a community
- Familiarize citizens with the elements of crimes, the various grades of crimes, the Pennsylvania Crimes Code, Vehicle Code and municipal ordinances
- Provide an understanding of the citizen's role in basic crime prevention.

The student's curriculum included a tour of the department, history of policing in the United States, discussions of applicable case law on arrests, statements and confessions, search and seizure and the use of force. Students had the opportunity to lift latent fingerprints and learned what is physical evidence and DNA. There were also presentation on drugs and drug paraphernalia, traffic enforcement and accident investigation, the use of canines and crime prevention.

The citizen students from Bath were Frank Wunderler and Karen Skipper, from Hanover Township Martha Kuhns, John Rosenthal, John Weber, Michale Coogan, Francis "Red" Fedor, Irv Good, Frank Colon, Karen Van Why, Edward Corrigan and Patricia Stonaker, from Lower Nazareth Township Barbara Hoell and Tract Hoell and from Chapman Borough Dorothy Niklos.

It was the consensus of the students that the program was interesting and enjoyable. It provided them with a better insight into the role of the police in their community.

## A Time of Transition in Harrisburg

HARRISBURG – January 2003 will be remembered as a time of transition here in the State Capitol. The 2003-04 Session of the Pennsylvania House of Representatives opened Jan. 7 with the election of Rep. Matthew J. Ryan (R-Delaware) to a historic sixth term as speaker.

Later in the month former Philadelphia Mayor Ed Rendell became the 45th governor of Pennsylvania.

Republicans hold a 108-94 majority in the House. There is one vacancy. This is the fifth consecutive session Republicans will control the House. It is the longest consecutive Republican tenure since the GOP controlled the House in the late 1940s and early 1950s.

In the state Senate the Republicans hold a 28-21 advantage with one vacancy.

One of the top priorities of the House in the new session will be education and dealing with growing property taxes. These two issues are difficult to separate as public schools receive most of their funding from property taxes.

With nearly half of the state budget already devoted to education, it is questionable how much more state taxpayers can do but we can encourage education innovation by giving schools more local options.

Health care is expected to remain a focus of the early days of the legislative session.

Last year the House took up some major initiatives to help our doctors, hospitals and more importantly, our patients address the medical malpractice insurance crisis. Yet apparently more still needs to be done due to the high costs of medical liability insurance for doctors and hospitals. Preserving Pennsylvania's world-class health care will be a major challenge.

With the national economy not growing at the rapid rate of the past few years, the House, Senate and Governor must work together in a bipartisan manner to pass a fiscally prudent spending plan.

Following the swearing in of House members, Schweiker in his final address to a Joint Session of the General Assembly, thanked legislators for their work to make Pennsylvania a healthier, safer and more economically secure place to live.

He also emphasized Pennsylvania's economic and fiscal stability. Thanks to fiscally prudent decisions when times were good, the Commonwealth's budget remains balanced and there is \$250 million in the rainy day fund. We are in good condition relative to other states.

Two-thirds of states report declining revenues and more than half of states face expenditures that exceed levels projected in their fiscal year 2003 budgets, according to the National Conference of State Legislatures' State Budget Update.

## Impressions

By State Senator Charles W. Dent, 16th Senatorial District

The end of 2002 marked the end of the Pennsylvania General Assembly's two-year Legislative Session. It is a good time to look back on some of the major issues that we considered during the Session.

The last two years saw changing economic conditions nationally, which severely impacted most state budgets. Fortunately, at a time when other states were raising taxes or cutting programs and services, Pennsylvania continued to reduce the tax burden on working families and job-creators. Pennsylvania was better prepared than many states to handle a tightening economy thanks to healthy reserves in the Rainy Day fund and good fiscal policies in the past. As a member of the Senate Appropriations Committee, I strongly backed those prudent steps.

A major highlight of the 2001-02 Legislative Session was the landmark investment in health care. The Legislature approved a sweeping tobacco settlement bill in 2001 that is dedicated to improving health care by providing health coverage to more needy Pennsylvanians, promoting smoking cessation and prevention programs and enabling more senior citizens to live independently in their homes, along with other initiatives.

Another important accomplishment was increased education funding and accountability. The Senate and House approved legislation that increased special education funding, established tutoring grants for families, expanded options for schools, and provided professional development opportunities and requirements for educators.

In the wake of the September 11, 2001 terrorist attacks, the Legislature approved measures to improve public safety and develop a coordinated Homeland Security Program in Pennsylvania. We passed a number of additional laws to better protect citizens from criminals and make Pennsylvania's legal system more equitable.

Reform measures targeting government and the courts were important developments, as well. The Legislature gave final approval to an election reform measure that will establish a statewide uniform voter registration system to protect the accuracy and integrity of Pennsylvania's voter registration rolls. We also approved legislation that gives citizens greater access to public records.

A major lawsuit reform measure replaced "joint and several liability" – under which a defendant found to be one-percent liable could be forced to pay 100 percent of the damages -- with proportional liability. The Legislature also approved significant medical malpractice reform legislation designed to ensure access to doctors, reduce costly litigation, improve patient safety, and strengthen physician-reporting requirements.

Under the heading of environmental protection, the Legislature approved bipartisan legislation that will launch the first comprehensive review of Pennsylvania's water supplies in more than 25 years.

Finally, the Session concluded with the passage of legislation protecting PACE prescription drug benefits for seniors who were in danger of losing their eligibility.

To be sure, plenty of work faces us in the upcoming 2003-04 Legislative Session. But, the 2001-02 session was a very productive one on behalf of Pennsylvania citizens.
