ARE YOU READY?**CRITICAL INFORMATION REGARDING LOCAL EARNED INCOME TAX (EIT) COLLECTION****Keystone Collections to Replace Berkheimer for Hanover Township Earned Income Tax Collection**

Hanover Township imposes an earned income and net profits tax (EIT tax) on all residents and non-residents who work in Hanover Township. Beginning in 2012, all Northampton County municipalities (except North Catasauqua) and school districts will have a single EIT collector, Keystone Collection Group. Also beginning 2012, taxpayers and employers will need to follow new rules in connection with the collection of local EIT. The EIT tax rate and exemptions will not increase as a result of these changes.

Pennsylvania Act 32 of 2008 (Act 32) mandates local EIT collection on a County wide-basis beginning 2012, and the use of a single tax collector. The County-wide tax collection district is known as the Northampton Tax Collection District (TCD). The TCD is governed by the Northampton Tax Collection Committee (TCC) which consists of appointed representatives from each municipality and school district in the TCD.

Act 32 requires the TCC to select a single EIT collector for the TCD. After reviewing the tax collection rates and capabilities of several tax collection firms, the TCC voted to appoint **Keystone Collections Group (www.keystonecollects.com)** as the EIT collector for Northampton TCD, effective 2012. The new collection commission rate of 1.48% is lower than the current rate for most of the municipalities and school districts within the TCD.

The transition from Berkheimer, the current EIT collector to Keystone will soon be underway. Keystone will be contacting all businesses in the TCD to provide information about the change and any new collection processes. Residents will have to file their 2012 earned income tax return with Keystone, but much of the process should stay the same.

The current EIT collector Berkheimer will continue to process the 2011 tax year payments and 2011 final returns until June 30, 2012. Thus, payments towards a taxpayer's 2011 tax obligation shall continue to be paid to the current collector (Berkheimer, until June 30, 2012) and the taxpayer's final 2011 return should be filed with the current EIT collector. Payments of the 2012 tax, beginning with the first quarter of 2012, shall be paid to Keystone Collection Group as the new 2012 EIT Collector. All payments made, and returns filed, after June 30, 2012, should be with Keystone.

Act 32 also requires uniform employer withholding, remittance, distribution and reporting. Act 32 establishes uniform statewide rules and regulations and provides for accountability, oversight and enforcement of the local EIT collection system. The Act also mandates that employers register with their TCD collector and have a "certificate of residency" form on file for each employee. Employers must automatically withhold and submit EIT for each employee. Taxpayers who are wage earners and whose wages are subject already to withholding should not be significantly impacted by the Act 32 changes.

These changes in EIT collection do not change the municipality's or school district's system for collection of the Local Service Tax.







A Responsible Budget Proposal

When Gov. Tom Corbett made his budget address in March, many of the initial responses to what he said were not favorable. While expressing displeasure for what he laid on the table that day, those who questioned him needed to keep in mind that the opinions he voiced were nothing more than proposals. No state budget ever passed in Pennsylvania has mirrored what was initially offered as a spending plan.

Budget addresses need to be viewed as the initial step in what is often a long and deeply involved negotiating process.

House Republicans have come out with a budget proposal of our own, an amendment/response to what the governor laid out. It concurs with some of the things he would like to see happen and addresses other elements we feel need dealt with in a different manner.

House Bill 1485, the response to Corbett's plan, agrees with his spending figure of \$27.3 billion. While there are signs that the economy is turning around, they are very elementary signs. Government needs to live within its means now more than ever. Holding the line on spending is a must, as we seek to be better stewards of taxpayer dollars. Pennsylvanians everywhere continue to be forced to do more with less. State government needs to do likewise.


To that end, our proposal reduces the amount of money budgeted for the Legislature by \$15.3 million. This is nothing new for our caucus, which has been more cost conscious over the last few years with issues such as staffing. House Bill 1485 is a continuation of that practice.

By far, the biggest adjustment to the Corbett budget proposal deals with education. While our school districts need to be more frugal in this economic climate, they are being asked by the governor's plan to cut far too deeply. Our proposal increases K-12 education funding by more than \$200 million. As a result, all Pennsylvania school districts would be supported at pre-federal stimulus (2008-09) levels.

House Bill 1485 also raises the amount of higher education funding by \$380 million over Corbett's proposal. It increases support for the State System of Higher Education by \$195 million, thus reducing the governor's proposed 54 percent cut to 15 percent, including lost stimulus money. The amendment also raises funding levels to state-related universities by \$180 million, again reducing the governor's proposed cut from 51 percent to 25 percent.

What allows us to increase support for education while maintaining a set spending figure is our treatment of welfare. Incidents of fraud, waste and abuse in the system have been uncovered by Auditor General Jack Wagner, but weren't sufficiently addressed by Corbett's plan. Our proposal cuts welfare spending by \$470 million. The Rendell administration acknowledged but failed to do anything about a 4 percent "error rate" in the welfare system. Welfare fraud robs the taxpayers and cheats the people who truly deserve such support. Our budget proposal confronts the problem head on.

Many legislators who have served in office longer than I say this is the most challenging budget we have ever had to craft. The economy, coupled with past practice by the previous administration, leave us in a hole that will not be easy to climb out. Tough choices must be made, something that is no different than many of you have been forced to do. We feel the proposal we have put forth balances difficult decisions with emphasis on support for essential areas, thus combining to keep Pennsylvania on track for the days when times are better.

❖ **LOCK YOUR DOORS, GARAGES AND CARS.** Most of the few crimes occurring in our township are crimes of opportunity. Don't give thieves the opportunity to make you a victim.

❖ **DO NOT LEAVE VALUABLES IN VIEW** from windows or doors, especially in the rear of the home, where criminals can easily spot valuables and break in to get them.

❖ **DO NOT LEAVE BIKES** and other toys **IN PLAIN VIEW ON THE LAWN.**

❖ **USE LIGHTS TO DETER CRIMINALS.** Using lights has been shown to be the best single deterrent of crime. Light up doors, driveways, and sidewalks; a combination of timers and motion detectors provides formidable protection, leading a thief to move on to easier targets.

❖ **USE DEADBOLT LOCKS WHEN POSSIBLE** and be sure that they move all the way into locking position, reaching the final click.

Colonial Regional Police

HISTORY

In 1995 the municipalities of Bath Borough, Hanover Township and Lower Nazareth Township organized the Colonial Regional Police Commission to provide police services to their municipalities. Prior to 1995 Bath Borough had their own department, Hanover Township had been receiving police services from the Pennsylvania State Police and Lower Nazareth Township received contractual police services from Nazareth Borough. In January of 2000 the department started to provide contractual police services to the Borough of Chapman. The total resident population of the jurisdiction is 20,000+ individuals.

COMMISSION

The Colonial Regional Police Commission is the governing and policy making body. The Chief of Police answers directly to the Commission and is charged with the overall supervision of the Department. Bath Borough, Hanover Township and Lower Nazareth Township are each represented by two elected officials from the municipality. One representative from each municipality is the primary delegate and one is an alternate. Each municipality has only one vote on Commission matters. An alternate can only vote on an issue in the absence of the primary delegate. Commission Members are appointed annually by their municipalities. The Commission Members annually elect a Chairman, Vice-Chairman and a Secretary-Treasurer. The Commission annually appoints a solicitor and a person to be the Commission Secretary. Currently Glenn R. Walbert is serving as the Chairman.

BUDGET

The Commission develops and approves the annual budget of the Police Department. The 2011 Budget of the Police Department is \$2,878,992.41 with Hanover's share \$1,481,269.37.

PERSONNEL

The Police Department became operational on October 1, 1995 and consisted of the Chief, eight officers and one clerical person. In November of 1995 six more officers and a part-time clerical person were employed bringing the total complement to 17. As of May 16, 2011, the authorized complement is 25 employees; the Chief, Deputy Chief, 4 Patrol Sergeants, 14 Patrol Officers, 1 Detective Sergeant, 2 Detectives and 2 full time administrative personnel.

PROGRAMS

The Department offers 24 hour a day, seven day a week service and provides K-9 services, D.A.R.E. instructions, Crime Prevention Programs, KIDS Card Program and Child Car Seat Safety Inspections. Members of the Department are active in drug enforcement as members of the Northampton County District Attorney's Drug Task Force and the Department is an active participant in the Lehigh Valley DUI Task Force.

EMPHASIS

Colonial Regional Police Department places strong emphasis on the enforcement of the Vehicle Code in the belief that the deaths, injuries and financial impact of automobile crashes cause more injury to citizens, their families and businesses than all types of other crimes together.

STATISTICS

In 2010, Colonial Regional Police Department investigated and/or responded to 9,006 incidents or complaints and was involved in 3,790 enforcement actions of violators of the Crimes Code, Vehicle Code or Municipal Ordinances.


2010 Budget Review *by Jay Finnigan*

The Township of Hanover continues to be financially sound. The Township of Hanover has committed itself to being fiscally responsible over the years and appropriately addressing Township needs.

To share some highlights from 2010, the Township paid off its 2006A and 2004 debt obligations early leaving only two remaining notes outstanding. Our debt service after 2015 will be just 30% of our current levels. The fund we established to provide for replacement of fire apparatus is developing nicely. The general fund did present a "loss" for the year, which were mainly the result of a large mercantile tax refund to a local corporation and the unexpected expense of a sinkhole repair. Across the board, the general fund functional categories of expense were all under budget, demonstrating our efforts to keep a tight rein on expenditures. Due to the current economy, assessed valuations of property in the township increased at a considerably lower trend, resulting in lower than expected tax revenue, which the Township was able to absorb given our current reserves. We are delighted that our sound reserves continue to allow us to meet the public service needs of our residence without the need for short term borrowing or deferring our repair and maintenance projects.

In addition, the Township's system of financial planning, budgeting and internal financial controls are well regarded, as official audits have demonstrated. The Township plans to continue its sound fiscal management to meet the challenges of the future.

RESIDENTIAL WASTE AND RECYCLING BILLING 2010 & 2011

In January each **residential property owner** received their 2011 Residential Waste & Recycling bill which had a discount date of March 15, 2011 and a due date of April 15, 2011. Bills that have not been paid received a reminder notice postcard, on or about May 6th. Please pay your bill as soon as possible to avoid additional fees and charges.

2010 DELINQUENT BILLS

Fifty-seven (57) homeowners who did not pay their 2010 bills after numerous billings and reminders had their properties liened to collect their fees. This was up from fifty-two (52) in 2009. The debt must be satisfied prior to a property being sold. Just so you understand the importance of paying your Waste and Recycling Bill. Single family residential properties (original bill \$295.00) liened will need to pay \$654.50 + accumulated interest and \$29.82 collection costs to satisfy the lien. Multifamily residential (original bill \$150.00 (collected via dumpster service)) will need to pay \$495.00 + accumulated interest and \$29.82 collection costs to satisfy the lien. Once the Township receives payment in full the lien will be removed from the property.



YARD WASTE INFORMATION REMINDER

The pickup will start in the northern most part of each sector on MONDAY (unless noted on the schedule available at www.hanovertwp-nc.org) and proceed southerly. Yard waste must be curbside NO LATER than 7:00 a.m. on the dates noted on the schedule. The yard waste truck will make only one pass through each sector during the week identified. Material must be placed curbside either in the

92-gallon Township container, other rigid container or YARD WASTE BAGS available at most hardware or building material stores. Containers and/or bags, other than the 92-gallon barrels provided by the Township must weigh less than 70 lbs. Yard waste placed in plastic bags will not be collected.

YARD WASTE ACCEPTED MATERIAL	NOT ACCEPTED
Leaves (1)	Grass(2)
Small Brush – up to 4” in diameter (no longer than 6 feet, tied & bundled)	Sod
Hedge & shrub trimmings, garden plants residue	Tree stumps
Christmas trees free of ornaments, lights, garland, tinsel & stands	

- (1) Leaves will be picked up starting the 2nd week of October continuing through the 1st week of December when raked to the curb.
- (2) Recycle your grass using a mulching mower or by cutting your lawn frequently and leaving the grass on the lawn. This does not contribute to thatch and provides an excellent fertilizer. You can place your grass out for the regular trash collection but this is not recommended by the Township or the Department of Environmental Protection.

Yard waste is only picked up where residents place refuse and recycling curbside for collection. If you have questions, please contact the Township @ 610.866.1140, ext 224.

SHADE TREE NEWS — BY SHADE TREE ADVISORY BOARD

NEW PARK TREES:

In the past year 33 new trees have been planted in Crawford and Troxell Parks. The trees include some new varieties for our parks: Black Gum, English Oak, Chinkapin Oak, Willow Oak, Black Maple, Autumn Blaze Maple, and Fall Fiesta Sugar Maple. The other trees planted include Red Oak, Bur Oak, Shingle Oak and Sweet Gum. In the years to come, these trees will be beautiful additions to our park system.

SUMMER TREE CARE:

WATER young trees deeply once a week if there is no rain

MULCH around tree, 2 – 3 inches deep with no mulch touching the trunk

REMOVE SPROUTS growing from the base of the tree

PERMIT REQUIREMENTS:

If a tree in the Township right-of-way dies, it must be replaced. Get a permit from the Township Office or on-line and replace the tree with one from the Approved List.

A live tree cannot be removed from the right-of-way without permission and a permit.

HANOVER FIRE COMPANY

Hanover Township Volunteer Fire Co #1 of Northampton County has been serving the residents, businesses, visitors and commuters of Hanover Township since 1943. The fire company has three divisions providing services to the community. The Fire Division provides firefighting and rescue services; Emergency Medical Service (EMS) Division provides ambulance services; and the Fire Police Division provides traffic control support services for the Fire and EMS Divisions. The fire company through these three divisions also supports community events within the township such as 5K runs, Asa Packer Fun Festival, Township carnival and many more events.

The manpower that enables the company to provide these emergency and non-emergency services consists principally of volunteers who provide their time and effort at no cost to Hanover Township. Not only do these volunteers pass Pennsylvania State qualification exams in order to become certified in providing emergency services, members must undergo continual training to keep current with trends in the emergency services and regularly practice these skills in order to be ready for any emergency. The amount of man-hours that these volunteers provide without compensation has never been calculated. However, we have many members that in addition to all the required training, respond to 200, 300 and even 400 emergency calls per year. Considering the amount of time these volunteers

ARE YOU READY?

CRITICAL INFORMATION REGARDING LOCAL EARNED INCOME TAX (EIT) COLLECTION

Critical EMPLOYER EIT Withholding Requirements under Act 32

Pennsylvania Act 32 of 2008 (Act 32) provides for significant changes in the collection of local earned income tax (EIT), including imposing new requirements on employers. The following are only some of the employer requirements under Act 32.

- Every employer must register with the designated local EIT Collector. Beginning 2012, Keystone Collections Group will be the single EIT Collector for all Northampton County municipalities and school districts, except North Catasauqua. For more information see Keystone's "Employer Resources" web page at www.keystonecollects.com. However, employers will send all tax payments and forms for all taxes withheld from employees in 2011 (including the fourth quarter of 2011) to their current collector.

- Employers must require each employee to complete the "Certificate of Residency" form provided by the Pennsylvania Department of Community and Economic Development (DCED).

- Every employer must deduct from payroll the greater of the employee's resident tax (where the employee lives) or the employee's nonresident tax (where the employee works).

- Employers must track and report the Political Subdivision Code for each employee. This may require modifications to your payroll system.

- Every employer will be required to file a quarterly return and submit the amount of income taxes deducted during the preceding calendar quarter.

- Every employer will be required to file an annual return.

These changes in EIT collection do not change the municipality's or the school district's system for collection of the Local Service Tax.

To help employers prepare for the transition to Act 32 compliance, Keystone Collections Group will be conducting free educational sessions. Keystone will introduce the new requirements related to employers, mandatory withholding and collection of earned income tax.

are involved in providing necessary emergency services, being on call for a potential emergency response, and training, it can be safely said that township property taxes would be considerably higher since the township does not have to hire personnel to perform these functions. Typically, manpower cost is the most expensive component of providing emergency services.

The fire company also has an active program for junior members. These junior members earn credits for community service required by the school district while becoming familiar with fire and ambulance equipment and learning some of the techniques important to the emergency services. There are two levels of the Junior program, those 14 and 15 years old and those that are 16 and 17 years old. The younger juniors can only participate in training and very limited non-emergency duties. The older 16 and 17 year olds can go on calls but are not allowed to enter any burning structures nor use any rescue tools at an auto accident. However, these older juniors perform many other functions at fires and accidents that let the fire fighters over the age of 18 focus on the important tasks such as putting out the fire or cutting a trapped person out of their vehicle. These junior members are carefully monitored in compliance with state guidelines. Additionally, the fire station provides a safe monitored place for them to 'hang out'. What does the fire company get out of the program? The fire company hopes that when the junior member turns 18 that he/she will want to become an active member. Many of our current members including the Fire Chief and 1st Asst. Chief both started out as Junior Firefighters.

There are many strains in providing EMS services that are not unique to Hanover Township. Principle among these is the diminished availability of volunteers. Modern society just about demands that both adults in a household work in order to maintain a decent standard of living and there are additional demands on their time if children exist in the family. Many families just do not have the time to raise a family, satisfy their other pursuits and still provide time for volunteer emergency services. To solve that problem, in 1998 Hanover in conjunction with three other municipalities formed TEAMS, a daytime staffing organization with paid professionals to provide EMS service. Each municipality had the crew based in their area for two weeks out of an eight week rotation. The crew would then answer EMS calls in the four municipalities (Bath, East Allen, Lower Nazareth & Hanover). The system worked well providing daytime EMS services for thirteen years but there have been challenges in recent years which were manageable. One of the more troubling problems was that the on-call ambulance could be stationed at a different station other than Hanover when the request EMS emergency services was in Hanover Township, this typically resulted in a longer than ideal response times in Hanover Township. Another problem was that if the crew was on a call in another municipality and there was a call in Hanover, another EMS squad (mutual-aid) was dispatched in their place which could also result in longer than ideal response times. The passage of Act 37 of 2009 by the legislature of the Commonwealth of PA made the use of the TEAMS concept in providing EMS services non-compliant. At the end of March TEAMS was disbanded, as a result of East Allen & Hecktown voting to withdraw. To satisfy the need for daytime EMS staffing the fire company hired two full time EMT's and several part-time EMT's to provide coverage from 6:00 AM to 6:00 PM.

The Township Board of Supervisors recently engaged the services of the Eastern Pennsylvania EMS Council to determine the most appropriate EMS Services for the residents, businesses and visitors to Hanover. The EMS Council provided four (4) recommendations/options to the Township and those recommendations/options are currently being weighed.
