Appointment of Joseph D' Amico, Esquire as Special Solicitor for Condemnation Action In re: CZM, II LLC C-48-CV-2024-07563 and its ancillary matter, CZM II, LLC v. Hanover Township C-48-CV-2025-07531

Mr. Giovanninni explained that the attorneys for 90 Highland, LLC., approached the Board of Supervisors relative to assistance for condemnation powers with respect to right-of-way and easements for 90 Highland Commercial Development. The attorneys were having issues with one of the properties that they needed easements from and the Township agreed to assist by using its condemnation power. An agreement was entered between the developer and the Township.

1. Mr. Gross moved the Board to appoint Joseph D'Amico Esquire or a partner with Fitzpatrick, Lentz and Bubba, P.C. as Special Solicitor to Hanover Township, Northampton County, in the matter of Condemnation of Property owned by CZM, II LLC docketed at Northampton County Civil Docket C-48-CV-2024-07563.

2026 Budget 2nd Discussion - Staff

Ms. Bucko provided a presentation and insight into the 2026 budget for the Board of Supervisors with some adjustments from the previous presentation.

The Board discussed whether they should change when the waste and recycling bills are due because of the cost increase and the elimination of the discount period to pay. The date that all payments must be in is April 15, 2026. If the due date is changed, it will need to be changed by Ordinance.

Sewer rates for the West District will increase from \$75.00 to \$102.00.

Jennifer Levins, 1370 Gaspar Avenue, shared information regarding her tax bill and that she would like to see the taxes being raised in the Township.

Scott Harney, 1065 Yorkshire Road, stated he is okay with the new amount of the trash bill. Mr. Harney shared that the Township has done a commendable job for the last 20+ years of keeping taxes even but would like to see the taxes grow slowly rather than quickly.

Community Center Roof - Discussion

Chris Devers, Exterior Building Solutions, who recently assisted with the 248 Building roof presented the Hanover Township Community roof replacement proposal. The Hanover Township Community Center roof is separated into 3 phases.

Phase 1: Flat roofs would cost \$200,000

Phase 2: Metal roofs and skylights would cost \$1,000,000 Phase 3: Flat roof with AC units would cost \$1,050,000

Total: \$2,250,000

Mr. Hudson explained that he would like to complete Phase 1 and Phase 3 in 2026 due to the rubber roofs and the lifespan. The HVAC units use a coolant that is no longer available so they are difficult to service when issues arise.

The Board would like to proceed with Phase 1 and Phase 3 and would like more information on the cost of repairs for Phase 2 with the metal roofs. Mr. Hudson stated he will work on getting more repair quotes. If the Board decides to move forward with Phase 2, the budget will need to be amended.

Monica Beaky had questions regarding the HVAC units. Ms. Beaky asked what kind of savings and efficiency would be seen with the new units. Mr. Hudson stated there isn't much of a difference.

Joseph Pepitone, 5772 Monocacy Drive, asked if the Township can switch to commercial HVAC units. Mr. Hudson explained that the air ducts are individual throughout the building for the 22 units currently being used.

The Hanover Township Fire Company also needs a roof replacement. The cost to repair the HTVFC roof would be around \$90,000.

Fire Tax - Discussion

Karen Peters, EMS Director and Jordan Isaac, President, of the Hanover Township Volunteer Fire Company presented to the Board a Q & A for cardiac equipment and compared the difference between a Basic Life Support (BLS) and Advanced Life Support (ALS).

Mark DeMasi, 4825 Matts Drive, stated he fully supports paramedics and shared his experience as a paramedic. Mr. DeMasi feels that the HTVC could benefit with the ALS.

Marguerite Georges, 4501 Susan Drive, stated that the fire company and EMS should be communicating and educating residents that the fire tax money is not going to the fire company or EMS. Ms. Georges feels that a lot of people may not know that. Ms. Georges suggested the fire company and EMS open up more about what they do and how the fundraising funds can benefit them.

Mr. Hudson stated that at the last meeting the Board discussed the fire tax budget with the purchasing of the ambulance. The expected fire tax income is about \$284,000. The Township spent \$245,000 on the ambulance leaving a balance of approximately \$40,000. If the Township would replace things by following the equipment schedule, the fire tax fund would be negative \$1 million in 2029.

The Board agreed that in order to follow the equipment schedule, the fire tax needs to be raised. In 2026, the fire tax should be raised by 0.25 mills to 0.75 mills.

Jennifer Levins, 1370 Gaspar Avenue, agreed with the tax increase.

Ms. Lawless noted she would like to raise the tax gradually.

Mr. Prendeville moved the Board to authorize the Secretary to advertise the proposed 2026 budget including a 0.25 mill fire tax increase for adoption at the December 16, 2025, Board of Supervisors meeting.
